Minnesotans filed 858 Chapter 7 and Chapter 13 Bankruptcies in October, 2018. In October, 2017, Minnesotans had filed 782 Chapter 7 and Chapter 13 Bankruptcies. That is an increase of 9.71%.

Thus far, in 2018, Minnesotans have filed 8,288 bankruptcy cases. Compared to this time in 2017, Minnesotans had filed 8,148 cases. That is an increase of 1.71% year over year.
