Minnesotans filed 923 Chapter 7 and Chapter 13 Bankruptcy cases in March, 2019. In March, 2018, Minnesotans had filed 996 Chapter 7 and Chapter 13 Bankruptcies. That is a decrease of 7.32% in case filings year over year in March.

Thus far, in 2019, Minnesotans have filed a total of 2,369 Chapter 7 and 13 Bankruptcy cases. This time in 2018, Minnesotans had filed a total of 2,413 Chapter 7 and 13 Bankruptcy cases. That is a decrease of 1.82% year over year.
