Minnesotans filed 948 Chapter 7 and Chapter 13 Bankruptcy cases in April, 2019. In April, 2018, Minnesotans had filed 977 Chapter 7 and Chapter 13 Bankruptcies. That is a decrease of 2.96% in case filings year over year in April.

Thus far, in 2019, Minnesotans have filed a total of 3,317 Chapter 7 and 13 Bankruptcy cases. This time in 2018, Minnesotans had filed a total of 3,390 Chapter 7 and 13 Bankruptcy cases. That is a decrease of 2.15% year over year.
